

STI Awareness

STI Awareness Week provides an opportunity to raise awareness about sexually transmitted infections, or STIs, and how they impact our lives; reduce STI-related stigma, fear, and discrimination; and ensure people have the tools and knowledge for prevention, testing, and treatment.

CDC estimates that about 20 percent of the U.S. population – approximately one in five people in the U.S. – had an STI on any given day in 2018, and STIs acquired that year cost the American health care system nearly \$16 billion in health care costs alone.

Did you know? All STIs can be treated and some can be cured. Many STIs have no symptoms. The only way you can be sure of your status is to get yourself tested. Anyone having sex can get an STI.

Health District Advisory Council

The Annual Health District Advisory Council meeting was held Wednesday, March 22nd at the Muskingum County Welcome Center. There were 50 attendees from 22 of 35 political subdivisions.

Abby Nguyen was reappointed to another 6-year term from April 1, 2023—March 31, 2029.

The Zanesville-Muskingum County Health Department serves the townships, villages, and cities of the county.

The chief executive of each of the villages, the president of the Muskingum County Board of Commissioners, and the chairperson of each township's board of trustees are the designated members of the District Advisory Council.



National Infant Immunization Week

National Infant Immunization Week (NIIW) highlights the importance of protecting infants and young children from vaccine-preventable diseases. This year, a primary focus is to ensure families stay on track for their children's well-child visits and routinely recommended vaccinations.

COVID-19 has caused many disruptions in families' lives – and in some cases, it has meant that children have missed or delayed their wellness checkups and vaccination, which are a critical part of ensuring children stay healthy. CDC and the American Academy of Pediatrics (AAP) recommend that children stay on track with their well-child appointments and routine vaccinations.

Most parents choose the safe, proven protection of vaccines. Giving babies the recommended vaccinations by age two is the best way to protect them from 14 serious childhood diseases, like whooping cough (pertussis) and measles.

Protect Your Family from Lead Poisoning

Children who live in houses built before 1978 are at greatest risk for lead poisoning. Lead dust from old paint can enter the body when we breathe. A child may swallow lead by eating chips of old paint.

Lead is especially hazardous to children younger than 6 years and can lead to many health problems including: nervous system and kidney damage; learning disabilities; speech, language, and behavior problems.

Good nutrition and repairing damaged painted surfaces or covering bare soil can temporarily reduce lead-based paint hazards.

The simplest and safest way to know is to have lead-based paint, dust, or soil tested by a professional.

Lead-based paint is usually not hazardous if it is in good condition and not located on a friction or impact surface like a door or a window.

Chipping, cracking, or damaged paint is hazardous and requires immediate attention.



Lead-based paint on surfaces that children may chew on or that are subject to heavy wear or use such as windows, doors, and porches also presents a hazard.

Lead can be found inside our home and outside in the air, soil, and water. It does not break down in the soil over time.

If you suspect you have lead-based paint, renovations or remodels should be done by certified lead abatement contractors.
